


Tracers with AMP® Enhancements

Through Tracers with AMP® you can now:

Expanded data collection supports risk assesment

New question types, in addition to Compliant/Noncompliant responses, are now available in Tracers with AMP. Users have the option to exclude responses from compliance reporting and the option to collect "Additional Information" to support question responses. Go beyond accreditation readiness activities into digital rounding with this new feature!

Here are the available question types a Program Administrator can use when creating tracers:



Get a cohesive picture of actionable data and draw critical connections by importing JCR mock survey findings

With a few clicks in our platform, the findings entered during your JCR mock surveys can populate into Tracers with AMP for reporting. JCR Mock Survey Findings will populate into the Organization Documentation section of Standards and Scoring; the data will also be available in the Standards Reports as well as Illuminate Analytics $^{\text{TM}}$. Tracers schedule and assignment enhancements

The addition of Tracers site-level scheduling will enable leaders to deploy and manage the Tracers program from the system or regional levels. Leaders may assign, communicate, and monitor expectations for each organization for the number and frequency of Tracer observations.

Score and monitor compliance as well as enter plans of correction for Life Safety Code® (K-tags)

If your organization subscribes to the CMS add on available with the Tracers platform you can now link K-tags to existing tracer questions or create new tracers using the new Life Safety Code templates. A new Life Safety Code Compliance dashboard is available in Illuminate AnalyticsTM. This dashboard will provide you the overall compliance by K-tag using the data entered in your Tracers observations. See figure B.

An API (interface) will be made available to all customers to create an automated process to securely transfer selected Tracers with AMP data on a regular basis to their data warehouses.

You will be able to download your Evidence of Standards Compliance (ESC) and view multiple cycles of Requirements for Improvement (RFI) data for the past 3 years.
